

**Sun Cities 4 Paws, Inc.**  
**50/50 Raffle Official Rules**

- 1. General.** By participating in the Sun Cities 4 Paws, Inc. (“4 Paws”) 50/50 Raffle (“Raffle”), entrants agree to be bound by these Official Rules and by the decisions of 4 Paws, which shall be binding and final as to all matters related to the Raffle. The Raffle is subject to all applicable federal, state and local laws, and is void where prohibited.
- 2. Jackpot.** The “Jackpot” shall be the total proceeds from raffle tickets sold for the Raffle drawing (“Raffle Tickets”), less reasonable expenses incurred by 4 Paws for the operation of the Raffle. In the event there is a surplus of expenses deducted, such proceeds shall be retained by 4 Paws. In the event an insufficient amount is deducted to cover 4 Paws’ expenses, 4 Paws shall absorb such expenses.
- 3. 4 Paws’ Proceeds.** 50% of the Jackpot will benefit 4 Paws, a 501(c)(3) organization, and the programs that 4 Paws supports.
- 4. Eligibility.** The Raffle is open only to all persons who, at the time of entry, are located in the State of Arizona and are 18 years of age or older. By participating in the Raffle entrants agree to be subject to these Official Rules. Raffle Tickets may not be purchased for a minor.
- 5. Purchasing Raffle Tickets.** All Raffle Tickets may be purchased as follows: [ENTER PRICE DETAILS AND “PURCHASE PERIOD”]. There is no limit to the number of Raffle Tickets an individual may purchase. Each entrant will receive a receipt corresponding to his/her purchased Raffle Ticket(s). Entries which are or appear to be tampered with are void. 4 Paws will be the sole judge of the validity and eligibility of all entries. All Raffle Ticket purchases are final, and no refunds or replacements will be issued by 4 Paws. Raffle Tickets are only valid for the drawing held [ENTER DETAILS ABOUT DRAWING].
- 6. Raffle Tickets are Not Tax Deductible.** The IRS has taken the position that amounts paid for chances to participate in raffles, lotteries, or similar programs are not gifts and, therefore, the price of the entry does not qualify as a deductible charitable contribution.
- 7. Prize.** The winner will receive a prize equal to 50% of the Jackpot.
- 8. Taxes.** The winner will be responsible for any and all travel, costs, federal, state and local income or excise taxes, fees, assessments and like charges associated with a prize. At the time of this printing, federal law requires that a tax withholding on certain prize values must be collected from winners upon award and distribution. Federal and state withholding laws are subject to change without notice. The withholding laws in effect at the time each prize is claimed will be followed. A shared prize claim by multiple persons shall not reduce any applicable withholding on the total amount awarded.
- 9. Selection of Winner.** Upon the conclusion of the applicable Purchase Period, one Raffle Ticket will be drawn by 4 Paws to determine the winner of the prize. The number of the

winning Raffle Ticket will be listed on [URL]. The winning number may also be publicly announced on social media platforms, and/or [OTHER WAYS OF ANNOUNCING, IF APPLICABLE] (as determined by 4 Paws).

- 10. Prize Claim.** Within 30 days of the drawing, the prize claimant must notify 4 Paws and present to 4 Paws the winning Raffle Ticket or other information which in 4 Paws' sole discretion evidences the claimant's ownership of the winning Raffle Ticket. Each prize claimant must provide 4 Paws with all information required to claim a prize (including tax identification information). In the event a claimant: (a) does not notify 4 Paws within 30 days of the drawing; (b) is ruled ineligible for any reason; (c) refuses the prize; or (d) does not return an executed release, the prize will be forfeited and will be retained by 4 Paws for charitable use. 4 Paws has no obligation to contact potential winners. All prizes will be sent to the winner via check within 30 days of the winner delivering the winning Raffle Ticket, executed release, and all other required documents to 4 Paws. For security and safety reasons, no cash payments will be made to Raffle winners.
- 11. Odds.** The odds of winning the Raffle depend on the number of Raffle Tickets purchased for the drawing.
- 12. Transfer of Raffle Tickets or Prize.** Persons who purchase Raffle Tickets may opt to give away their Raffle Tickets to other eligible persons, but in doing so the purchaser waives any claim he/she might otherwise have to the prize. Purchasers of Raffle Tickets may not re-sell their Raffle Tickets to other parties, and may not knowingly give Raffle Tickets away to others for the purpose of allowing those other parties to re-sell such Raffle Tickets. All Raffle Tickets which have been resold in violation of these Official Rules shall be void. All individuals who resell, purchase, or receive Raffle Tickets in violation of these Official Rules shall be ineligible to participate in the Raffle or to win a prize. A winner may transfer his/her prize to a third party provided that the following conditions are met: (a) the transferee would have otherwise been eligible to enter the Raffle (age 18 or older); (b) the transferee shall be responsible for all taxes and costs described in these Official Rules; and (c) the transferee shall be bound by all terms and conditions of these Official Rules that are applicable to the winner.
- 13. Judges.** The Raffle will be conducted and supervised by 4 Paws, whose decisions are final. 4 Paws reserves the right to modify these Official Rules at any time. 4 Paws reserves the right, in its sole discretion, to cancel or suspend the Raffle should unauthorized human intervention or other causes corrupt the administration, security, fairness, integrity or proper operation of the Raffle.
- 14. Release of Liability.** By entering into the Raffle, all entrants agree to: (a) be bound by these Official Rules; and (b) release 4 Paws and any parent corporations, subsidiaries and affiliates, together with their owners, partners, employees, officers, directors, sponsors, and agents, including advertising and promotion agencies from any and all liability with respect to any injury, damage or loss that may occur, directly or indirectly, in whole or in part, from the participation in the Raffle, or from any travel or activity related to the receipt or use of any prize.

**15. Publicity Release.** Each winner, by accepting a prize, grants 4 Paws and its designees and affiliates full permission, except where legally prohibited, to use such winner's name, address (city and state only), photograph, voice and/or other likeness, and prize information for advertising, trade and promotional purposes without further compensation and without notice, review or approval, in all media now known or hereafter discovered, worldwide and in perpetuity. Each winner shall execute all documents that 4 Paws may require to be signed in connection with this release.

**16. Governing Law.** The Raffle and these Official Rules shall be subject to and governed by the laws of the State of Arizona. If a court of competent jurisdiction finds that any provision of these Official Rules, or their application to a particular persons or circumstances, is invalid or unenforceable to any extent, then the remainder of these Official Rules shall remain enforceable to the fullest extent permitted by law. The venue for any cause of action arising out of the Raffle or these Official Rules shall be located in Maricopa County, Arizona.
